**1. Evaluation context**

Established in 1951, the International Organization for Migration (IOM) is the UN Migration Agency. The health promotion and assistance for migrants programme area caters its strategy and activities to the needs of migrant populations and the changing requirements of Member States to address the health of migrants. IOM projects in this area provide **access to high-quality health services for migrants** and undertake substantial amount of operational research to **promote evidence-based migration health policies.**

**IOM Project to which the Consultancy is contributing:** This consultancy will complement the project “Fostering health and protection to vulnerable migrants transiting through Morocco, Egypt, Libya, Tunisia and Yemen,” in its aim to improve health and protection of migrants and migration-affected communities in the countries covered by mapping the migration health profile. Through the network established along the lifespan of this project the Migration Health Country Profiles can be used as tool in reaching out to policymakers and key actors in the field of migration and health to pursue identified research agenda and include relevant evidence in the national policies and programs.

**2. Terms of reference**

- Assist the five countries of the project: Morocco, Tunisia, Egypt, Libya and Yemen in the creation of a ‘migration health data reference group’
- Identify sources of migration and health data at the national level – (1) traditional or routine data sources, and (2) non-traditional or agency-based sources
- Map Existing Domestic, policy and legal frameworks related to migration and health

- Map existing Health and social services available/provided to migrants/migrant groups
